**CONSIDERING** that the Government, by Decree No. 2016-706 / PRN, dated December 23<sup>rd</sup>, 2016, created MCA-Niger as the control and management body for the implementation of the Compact (the "Decree");

**CONSIDERING FINALLY** that the fifth regular meeting of the Board of Directors of August 7<sup>th</sup> 2018 has been regularly convened and held in the meeting room of Hotel Soluxe, and that the quorum has been duly attained in accordance with the provisions of Section 3.12 of the MCA Niger By laws;
