- (ii) Decree N°2016-706/PRN, dated December 23, 2016, on the creation, attributes, composition and functions of MCA-Niger;

### 1. Opening session

#### 1.1. Opening session: For Approval

#### A – Review of the notice of meeting and adoption of the Agenda

The adopted Agenda includes a single item which is: Board Approval Process for Urgent Decisions by written consent in the framework of the Covid-19 pandemic.

#### **B.** Discussions

**Summary of discussions**: The health situation related to the Coronavirus or Covid-19 pandemic that is affecting the world and Niger has led the Government to adopt preventive measures, including a ban on all gatherings. More globally, the prevention of the spread of the Covid-19 disease consists of the respect of certain barrier measures, including restrictions to physical meetings of the Board.

MCA-Niger's General Directorate has therefore developed a Contingency Plan to ensure the health and safety of its staff in the workplace by recommending mitigation measures. As part of this plan, all MCA-Niger personnel have been under home confinement and telecommuting since March 25, 2020; this measure is expected to last until at least April 20, 2020.

In this context, the Chairperson of the Board and the General Directorate submit to the Board for approval an exceptional procedure for making urgent decisions by written consent in accordance with Section 3.12 (b) (iv) of the Internal Regulations. The measure consists in adopting the electronic consultation, the process which is the following:

- Each Board member shall receive, by e-mail, a request for approval of a written draft resolution:
- Each member of the Board transmits, by e-mail, his or her response within 5 calendar days.

The use of emergency decision making process by electronic written consultation will be in effect until otherwise decided by the Board.

Discussions on this item being concluded, the Chairperson put to the vote the adoption of the board resolution  $N^{\circ}01$ .
